Future Energy Park Inc., by Application 28154-A003, registered on April 17, 2023, applied to the Alberta Utilities Commission for approval to construct and operate the 30-megawatt (MW) cogeneration power plant designated as the Future Energy Park Power Plant, along the eastern edge of the city of Calgary.

Pursuant to sections 11 and 19 of the *Hydro and Electric Energy Act*, the Commission approved the application in Decision 28154-D01-2023,¹ and granted an approval to Future Energy Park Inc. to construct and operate the power plant, subject to the provisions of the *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders made under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

- 1. The power plant shall be located in the southeast quarter of Section 1, Township 24, Range 29, west of the Fourth Meridian, as further described in the application.
- 2. The power plant shall consist of:
 - two 15-MW Solar Titan 130-23001S Axial GSC natural gas-fired turbine generators
 - one 4-MW diesel-fired emergency generator
 - one 1,000-kilowatt (kW) natural gas-fired startup generator
- 3. Unless otherwise authorized by the Commission, construction of the power plant shall be completed by June 30, 2025.
- 4. Future Energy Park Inc. shall notify the Commission within 30 days of completing the power plant.
- 5. Future Energy Park Inc. shall obtain Commission approval prior to making any substantive changes to the power plant or substantially varying the design or specifications of the power plant from what was stated in the application or what the Commission has approved.
- 6. This approval is not transferable unless approved by the Commission.

The Commission may cancel or suspend this approval, in whole or in part, in accordance with Section 41 of the *Hydro and Electric Energy Act*, or may review this approval, in whole or in part upon its own motion, or upon an application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*.

The Commission may, no later than 60 days from the date of this approval and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected approval on its website.
